

INVITATION FOR EXPRESSIONS OF INTEREST

UPGRADE OF COMMUNICATION, NAVIGATION, SURVEILLANCE AND AIR TRAFFIC MANAGEMENT (CNS/ATM) SYSTEMS - Replacement of Equipment

- 1. The GUYANA CIVIL AVIATION AUTHORITY (GCAA) is inviting eligible and qualified persons/contractors/companies to submit Expressions of Interest (EOI) to carry out the works listed in Lots 1 and 2 below, located at the Cheddi Jagan International Airport, Timehri and at ten (10) interior aerodromes. Interested specialists would be required to tender for the supply, installation, integration, training, and commissioning for these systems divided in two (2) different lots:
- Lot 1 Design and build one (1) Automatic Weather Observation System (AWOS) CAT II.
- Lot 2 Design and build Micro Automatic Weather Observation System (M-AWOS).

Note: Interested persons/contractors/companies should be prepared to offer one or both lots as a package.

Interested and eligible Firms are expected to submit the documents listed below to meet the minimum criteria:

- **Business Registration**
- ii. Valid GRA Tax Compliance Certificate or equivalent
- iii. Valid National Insurance Compliance or equivalent
- iv. A comprehensive company background/profile
- v. Proof of having successfully completed three (3) assignments of similar nature as the lead or as part of a consortium; and
- vi. Evidence that the proposed staff have the technical capability to undertake the assignment.
