## IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 140 (1) OF THE CIVIL AVIATION ACT, I MAKE THE FOLLOWING REGULATIONS: -

1. These Regulations, which amend the Civil Aviation (Air Navigation) Regulations\*, may be cited as the Civil Aviation (Air Navigation) (Amendment) Regulations 2022.

#### **UNMANNED AERIAL VEHICLE (UAV)**

For the purpose of this Schedule –

"aerial work" means an aircraft operation in which an aircraft is used for specialised services such as agriculture, construction, photography, surveying, search and rescue, observation and patrol, aerial advertisement, etc.;

"aerodrome" means a defined area on land or water (including any buildings, installations and equipment) intended to be used either wholly or in part for the arrival, departure and surface movement of aircraft;

"aircraft" means any machine that can derive support in the atmosphere from the reactions of the air other than the reactions of the air against the earth's surface;

"commercial operation" means an operation where the Unmanned Aerial Vehicle (UAV) flight is being conducted for business purposes (mapping, security surveillance wildlife

survey, aerial application, etc.) other than commercial air transport, in return for specific remuneration or form of valuable consideration;

"large UAV" means a UAV with a maximum take-off mass greater than 150kg (or for airships, more than a 100m3 envelope);

"Maximum Take-off Mass (MTOM)" often referred to as "Maximum Take-off Weight (MTOW), of an aircraft" means a value defined by the aircraft manufacturer. It is the maximum mass at which the aircraft is certified for take-off due to structural or other limits. MTOW is usually specified in units of kilograms or pounds;

"medium UAV" means a UAV with a maximum take-off mass of 25kg and less than or equal to 150 kg (or, for airships, an envelope of 100m3 or less);

"micro UAV" means a UAV with a maximum take-off mass of 100g or less;

"prohibited area" means an airspace of defined dimensions, above the land areas or territorial waters of Guyana, within which the flight of aircraft is prohibited except where permission is granted by the Guyana Civil Aviation Authority;

"Recreational Operations" means an operation where the UAV flight is being conducted for leisure, sport, or fun purposes only with no return for specific remuneration or form of valuable consideration;

"small UAV" means a UAV with a maximum take-off mass greater than 2kg and less than 25kg;

"Unmanned Aerial Vehicle (UAV)" means an aircraft, capable of being flown without a pilot being on board that aircraft, either autonomously, or controlled remotely by a pilot located outside the aircraft and includes drones, remotely piloted aircraft systems or any other such aerial vehicles remotely controlled and without a human pilot on-board;

"Unmanned Aerial Vehicles Air Operator Certificate (UOC)" means the approval granted by the Authority to an operator, allowing it use UAVs for commercial operations and aerial work operations where the MTOM of the UAV is 15kg or greater;

"very small" means a UAV with a maximum take-off of more than 100g and less than 2k.
